	The <b>Original passport</b> should be valid for at least 3 months beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. The passport must have been issued within the last 10 years.
	Copy of <b>previous visas and stamps</b> of the applicant's old passport(s) <i>if any</i> .
	Copy of <b>name or surname change certificate</b> , if applicable.
	<input type="checkbox"/> <b>Marriage certificate</b> <i>if you are married to an EU/EEA citizen (original + 1 copy)</i> <input type="checkbox"/> <b>Birth certificate</b> <i>if one or both of your parents are EU/EEA citizen (original + 1 copy)</i>
	<b>Documentation that the applicant joins or accompanies the EU/EEA citizen</b> ( <i>proof that the EU/EEA resides in the host Member State (see above) or a confirmation that the EU/EEA will travel to the host Member State</i> ).
	Overseas <b>travel medical insurance is not</b> required but the embassy strongly <b>recommends</b> that you always travel with a valid <b>health/travel insurance</b>

**Note:** Official documents marked with \* must be verified by the competent local authority. Verification must be maximum 3 months old. A certified translation in English must be attached to any documents in Vietnamese.
