	<b>Visa Fee payment receipt</b> printed from <a href="https://applyvisa.um.dk/">https://applyvisa.um.dk/</a>
	The <b>Original passport</b> should be valid for at least 3 months beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. The passport must have been issued within the last 10 years.
	Copy of <b>previous visas and stamps</b> of the applicant's old passport(s) <i>if any</i> .
	Copy of <b>name or surname change certificate</b> , if applicable.
	<b>Proof of integration:</b> into the country of residence: Household registration record.
	<b><u>Documents from employer/company:</u></b> If the applicant is employed: 1) the last three payslips, 2) labour contract or original documents confirming employment at recent date, 3) approval for holidays are required. - If the applicant is a company owner or self-employed: certificate of registrations of the company* and statement of taxes payment are required. - If the applicant is retired: Pension statement is required
	<b><u>Invitation</u></b> Invitation, entry tickets, enrolments or programmes stating (wherever possible) the name of the host organisation and the length of stay or any other appropriate document indicating the purpose of the journey.
	<b><u>Documentation of funds to cover the trip.</u></b> <i>According to the Danish Immigration Service you must have the <b>necessary means</b> to pay for your stay and return trip. As a general rule, you must have at your disposal approx. DKK 350 per day if you are staying in a private home and your host will cover all costs. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. 	<b><u>Proof of lodging:</u></b> Hotel reservation, rental of holiday home, campus residence reservation – if not hosted in a private accommodation.
	<b><u>If the applicant is minor accompanying parents:</u></b> - Birth certificate of the applicant * - Copies of the ID cards of the parents and guardians. * - If you are travelling with only one of your parents: <input type="checkbox"/> A letter of consent written and signed by a non-accompanying parent and guardian, except in cases of an accompanying parent having sole custody, and <input type="checkbox"/> An original and a copy of certificate of sole custody (if applicable)
	<b><u>Documentation providing clear information about the trip, including:</u></b> 1.Round trip reservation/booking Flight/train/ferry reservation with fixed travel dates of maximum 90 days to Denmark and other Schengen countries. <b>(Do not buy the ticket until a visa has been granted).</b> 2. Confirmation of accommodation in Denmark (and other Schengen countries, if the applicant is going to other countries on the same trip) 3. Entry tickets for fairs and congresses (if any)
	<b><u>Original compulsory travel medical insurance</u></b> , covering the entire of intended stay, valid for all Schengen countries covering any medical expenses of at least 30,000 Euro as well as urgent medical attention, emergency hospital treatment or death during your stay, repatriation to Vietnam/resident country

**Note:** Official documents marked with \* must be verified by the competent local authority. Verification must be maximum 3 months old. A certified translation in English must be attached to any documents in Vietnamese.
